## CODE OF ETHICS OF BRAZIL FRIENDLY NETWORK

The Easy Network Brazil is a company that has its values founded on respect for their consultants, Social Responsibility and Ethics in relationships.

The Network Code of Ethics Easy Brazil provides general guidelines for a good relationship between the Network Easy Brazil and its Distributors and the relation of each other Distributors.

The goal is to ensure that the criteria of justice and equality of conditions are met in the most varied situations, ensuring a uniform standard of excellence.

As a set of policies and principles that provide the necessary security to the Business Network Easy Brazil, the Code of Ethics Network Easy Brazil is an instrument that seeks satisfaction and the realization of these basic principles for a harmonious and just relationship.

This Code has all the necessary rules for the activity developed by Network Distributors Easy Brazil are guided by ethics, the respect and the responsibility, and the Network Easy Brazil will adopt all means to fit him to ensure that the rules governed this manual is fulfilled.

Follow according to the guidelines set out here allows you to make sure that opportunities will be fair and equal for all, and ensure the Distributors maximum freedom, so that they can employ any techniques, skills or creative methodologies to develop their business and present the opportunity for new distributors.

Acting in accordance with the rules of the company, who wins is you and your business.

### 1. Network Business

The Easy Network Brazil leaves complete freedom to the Distributors seek, recruit and sponsor new Distributors, but if you do have to be in accordance with the ethics and legality.

Offer the business opportunity, sponsor and train are key to Rebate System Network Easy Brazil. Knowing this, the Network Easy Brazil encourages a healthy environment and responsible for its Distributors.

Based on these assumptions are duties of Distributors:

- a) Working with loyalty and honesty in the creation and preservation of its network;
- b) Possess and give concrete, clear and true about the products, services and terms of payment and delivery, and provide accurate answers to the questions of Distributors and Consumers;
- c) Respect Distributors and Consumer Products Network Easy Brazil;
- d) Keep your behavior so Ethical, Legal and Moral;
- e) Preserving Easy Network Brazil from any liability arising from its action or omission which may have caused damage to third parties;
- f) Be true during the presentation of goods and Network business plan Easy Brazil without using untrue or misleading comparative standards simulations;
- g) Not to perform any act that would create an undue payment of bonuses;
- h) Comply with all existing rules under Brazilian law, especially those of the Consumer Protection Code, Civil Code and Penal Code;
- i) Sell Products Network Easy Brazil under the conditions suggested by the company, serving as sole and exclusive parameter of Independent Distributors;
- j) the marketing of products of the Easy Network with values lower than those suggested in the Company's official website provided for in the Regulation is not allowed;

- k) Not present to third parties as an employee or representative of Brazil Easy Network, sign or not sign any agreement or document on behalf of Network Easy Brazil;
- l) Treat with respect and education officials Network Easy Brazil in order to maintain a healthy environment;
- m) Use the Network Communication Channels Easy Brazil if you have problems with the Company.
- n) Consumer offer accurate and complete explanations of the product, purchasing conditions and terms of payment and delivery, and the right to repent and return policies.
- o) Provide accurate and understandable answers to consumer questions regarding the benefits of each product, forms of use and contraindications that may exist depending on each product.

It is prohibited to Distributor Network Easy Brazil:

- a) Using recruitment practices that are verified misleading, unfair or to induce the applicant, participant or consumer into error;
- b) Making derogatory statements or discouraging to the Company or against another Independent Distributor and / or point of support;
- c) Crave, entice or by any method, trying to recruit Distributors already registered or pre-registered on the Web Easy Brazil, or have already established a relationship with another Distributor Network Easy Brazil;
- d) Make any false or misleading statements about the products, the business plan, this manual, the Company, of its management board or other distributors;
- e) Induce a person to purchase goods or services from the perspective of obtaining advantage in exchange for the indication of potential consumers;
- f) Perform any acts that are not guided by the honesty, integrity, dignity, professionalism, respect, responsibility and building other Distributors Network Easy Brazil;
- g) Advertising by any means, saying that imply hiring employees from the network Easy Brazil;
- h) Use the name or Network Brand Easy Brazil Corporate Institutional form or in newspapers, printed materials, websites or any other media without prior authorization. In this case, the Distributor must enter your personal data and make it clear, especially in letters, treat yourself to an independent material, without any connection to the network Easy Brazil.
- i) Act or assume obligations on behalf of Network Easy Brazil Corporate or Institutional form;
- j) Making derogatory comments about other Distributors, the Network itself Easy Brazil or even competitors as a way of obtaining advantage;
- k) Promote the sale of products and services that do not comply with those offered by Network Easy Brazil;
- l) Using documents, passwords, codes or data from other Distributors without your express permission;
- m) Access the Virtual Office from another distributor without their express permission;
- n) Do line change, cross sponsorship or grooming;
- o) Engage in illegal activities or that may generate discredit Network Easy Brazil or its business model;
- p) Practice or participate in any act or omission which manages discredit or dissatisfaction to other distributors or consumers;
- q) Disparage, defame or utter any derogatory opinion about other companies, competitor or not the network Easy Brazil, as well as weaving product comparisons or services with intent to disparage

other people's brand, making misleading claims. The points of comparison should be based on facts which can be substantiated;

- r) The Easy Network Brazil does not support your Distributor to entice networks of other companies.
- s) Violators Distributors may be penalized by temporary suspension of the ID or even permanent suspension Distributor Network Easy Brazil.
- t) Violate the rules of this manual of Ethics and Discipline Network Easy Brazil.

Proven cases considered unethical will be subject to:

- a) Notification by the Legal Department of Network Easy Brazil;
- b) Register lock indefinitely;
- c) Suspension of Registration and Cancellation.

## **General rules**

When you start the retail activity, the Independent Distributor and / or Point Support Network Easy Brazil must, even if it is unsolicited, present with clarity and authenticity, identifying the company the products you are selling, the nature of and the goal his approach to the potential consumer or distributor;

The Easy Network Brazil are free to set prices and bonuses of goods and services sold, always followed the criteria for the company to make a profit and pay all bonus Distributor;

Each product offered on the site Network Easy Brazil has PV and PA variable. This information will be highlighted in the description of each product;

PV's generated on purchases are credited automatically after receipt of payment;

The PA's generated on purchases go to the network and the calculation is monthly;

Payments of your guests: The system automatically deducts all who have achieved any level below you;

Network Easy Brazil, as a system of free access and ease of registration and product purchases, is not responsible for meetings, seminars or any act concerning the training of its subscribers, being the sole responsibility of each seek information that will be available on the site.

## **2. Process and Disciplinary Committee**

The Disciplinary Commission is the competent body for conducting and analyzing the cases involving violation of the Ethics Handbook and Discipline Network Easy Brazil, the Company Policies, or any other regulations applicable to the network Easy Brazil and its Distributors.

The Disciplinary Committee shall consist of two (2) members of the Board and Distributors personally invited by the presidents of Brazil Easy Network.

Disciplinary proceedings are the instrument to determine the responsibility of each and every participant, individual or legal entity, the direct sales system and relationships subsidies developed by Network Easy Brazil.

The Disciplinary Committee shall exercise its activities independently and impartially, assured the confidentiality necessary for the elucidation of fact or required by the interest of the network Easy Brazil.

Meetings and hearings of the committees shall be reserved character.

The disciplinary process unfolds in the following phases:

- I. Establishment, with the act of description and classification of the offense from any Distributor;
- II. Instruction, which comprises the step of evidence, defense and decision.
- III. The Disciplinary Process will not start the craft, but will depend on charge, writing, with a brief summary of the facts and signed for a minimum of a Distributor Network Easy Brazil and may be in physical form, addressed to the address of the Network Easy Brazil, or virtual, to [atendimento@redefacilbrasil.com.br](mailto:atendimento@redefacilbrasil.com.br).

Empty and without a minimum of reasonableness allegations in the indictment will not be accepted.

The deadline for completion of the disciplinary process will depend on the complexity and seriousness of the facts involved, but will not exceed twelve (12) months from the date of delivery of the complaint.

The process shall comply with the adversarial principle, assured the accused legal defense to be exercised within 10 (ten) days after the science of initiation of disciplinary proceedings, he may make use of all the means and resources allowed by law.

The lack of defense of the accused will result in the acceptance of the facts alleged against him.

In its investigation, the Disciplinary Committee of the Network Easy Brazil may, in its sole discretion, promote the taking of evidence, confrontations, investigations and appropriate steps, in order to collect evidence to elucidate the facts.

The Disciplinary Committee of the Network Easy Brazil may deny requests considered naughty, merely dilatory or no interest to the clarification of the facts.

In the event of veracity of evidence of a breach of any provision of the Ethics Manual, the Network Easy Brazil may adopt any measures it considers appropriate to prevent irreparable damage to the Company or any of its distributors, including but not limited to, suspension temporary ID and activities for the time that lasts the Disciplinary Process.

The decision will always be conclusive as to the innocence or the liability of the accused.

Recognized the responsibility of the accused, depending on the violation, the Commission will indicate the applicable sanction, consisting of:

- I. formal retraction;
- II. temporary suspension of ID and activities (in this case the Distributor will lose the right to the bonus during the period of suspension);
- III. Fines of 30% of the average bonus for the last 6 months. If not enough PV balance, the distributor must credit the amount to the bank account of Easy Network Brazil.
- IV. definitive lock ID and loss of any right over the net.

In the case of the decision to conclude the innocence of the accused who had his temporarily suspended activity, shall not be paid any indemnity or retroactive refund.

### **3. Advertising and marketing**

The Distributor is not an employee of Easy Network Brazil. Identification on business cards, email signatures, websites, hiring and / or disclosure in ads and events is only permitted as "Independent Distributor".

the use of the trademark of Network Easy Brazil and its products in the domains and subdomains in Internet addresses except by express authorization of the Company is not permitted.

The disclosure of products Network Easy Brazil on personal sites, blogs or social networks is allowed as long as accompanied by the Independent Distributors of identification, not featuring at all, as the official website of the Network Easy Brazil.

It is allowed the use of brochures, catalogs, business cards and other printed materials produced or authorized by Network Easy Brazil.

outreach events are allowed within the approved standards and published by Network Easy Brazil.

### **4. Violation of rules established by this Regulation**

Any Distributor may report violations of the rules described in this manual and all the Rules and Regulations published by the Company, in order to preserve the quality of relationships and the company's image in the market.

The Distributor is responsible Sponsor, within their means, to ensure that each of the Distributors of your network know the Rules, Regulations and Company Policies, as well as its obligations as an Independent Distributor.

Cases where proven the offense will be punished by warning, suspension or even cancellation of the registration.

### **5. indemnities**

Is responsible Distributor for compensation Network Easy Brazil on any action, claim, demand, process, fine, penalty and costs arising from the violation of any law or regulation applicable to the distribution activities, without prejudice to other rights of Easy Network Brazil under this Regulation.

The Easy Network Brazil will not be responsible for damage, loss or Independent Distributor's legal costs arising in the act, offense, representation or statement of any other Independent Distributor.

### **6. Payments (Redemptions) and transfer points**

Once calculated your score on the last business day of each month, their PA's are zeroed. On the first day of each month begin to be accounted new PA's of the month.

The Grid system Easy Brazil calculates the PA's all purchases with payment confirmed from the first to the last business day of each month. automatically they will be deducted all who have achieved any level below you. After the consolidation of the data, if you have a balance of PA, this becomes PV and credit is released in your Virtual Office.

The points credited to the Independent Distributor's account and / or point of support will be valid for one (1) year.



If you do not make any purchase and have balance in PV, this value will be available in your Virtual Office to be used in a next purchase, or request redemption in accordance with the assumptions mentioned in this Regulation.

The points available in the Virtual Office Support Point may be used only for new purchases is not possible to request redemptions or transfers.

#### 6.1 Assumptions to request rescue and score the transfer:

- The bank account to credit, it shall be the holder of the registration with the network Easy Brazil;
- Must have minimum amount of PV - minimum value established in the Central Distributor;
- Purchase with payment confirmed with minimum released Distributor Central in the month preceding the redemption request.
- For redemptions above R \$ 1,000.00 the Distributor must send the Bonus Receiving Statement with Firm Recognition for the Office of Network Easy Brazil stating that the payment of income tax is your responsibility. This statement shall be valid for one year. (Statement available at the Central Distributor).

#### 6.2 Deadlines

The redemption request points should be carried out through the Virtual Office, where the Distributor will indicate a bank account of their ownership to credit the requested amount.

After requesting a withdrawal, the information provided will be sent to the Financial Sector Network Easy Brazil, which will be validated, and if there is any disagreement, will be returned to the Distributor and no credit, a new redemption request is necessary considering and / or correcting the data provided by Financial.

The value of the bank transfer rate and points is a minimum charge of operating and variable cost determined by Network Easy Brazil and will be deducted from the distributor at the time of redemption request or transfer points.

The deadline for redemption request the service is up to 10 working days after the request made in the Virtual Office.

In cases of transfer points to another distributor and / or point of support, so completed the request in virtual office, the transfer of points occurs automatically, with the registered redemptions within the policy. The Easy Network Brazil is not responsible for the information provided at the time of redemption and stresses that passwords and bank details are personal and not transferable.

### **7. Tax collection**

It is the sole responsibility of the Independent Distributor and / or Point Support the collection of all taxes received bonuses Network Easy Brazil.

### **8. Order cancellations**

When the client makes a request, once the payment is confirmed in the system Network Easy Brazil, bonuses are generated (PV and PA) according to the description of each product on the company website. When there is cancellation of the request, automatically bonuses are taken both Network (PA) as the direct beneficiaries (PV).

## 9. Commercialization

Direct selling should be understood as one in which goods and services are presented directly to the consumer, through explanations and personal statements.

### 9.1 "Door to door"

In Brazil, in general, the direct seller is an autonomous and independent dealer who buys products of the direct sales companies and resells them to its customers, with a profit margin.

The system adopted by Network Easy Brazil for the distribution of products is direct selling "door to door" or "Door to Door", where the Distributor Network Easy Brazil moves to the home or consumer location, makes the presentation, clarifications questions, do demonstrations and selling the product.

The premise of the direct selling door to door, so it is advertise, sell and distribute products and / or services through direct relationships and contacts.

### 9.2 Online sales

Selling products online is one of the means most used in the marketing of products and services.

With this in mind, the Network Easy Brazil understands that people are free to work well with this tool, however, that such negotiations take place in an ethical and healthy, you must follow the rules and regulations that are in the Policies, Terms and Regulations network Easy Brazil mainly with the values prevailing in the online market.

### 9.3 Resale prices

resale prices practiced in the products, should necessarily be the same practiced by Network Easy Brazil, thus ensuring harmony among the distributors who do the door to door sales as Online Distributors.

The information of the values of the products are on the official website of the company [[www.redefacilbrasil.com.br](http://www.redefacilbrasil.com.br)] and the Distributor and / or point of support may not resell for less than the minimum unit of each product that is on site.

### 9.4 irregularities

If it is detected that a distributor is selling the products of Network Easy Brazil with values below the minimum proposed on the official website will be subject to disciplinary action, and these may vary according to the degree and recurrence:

formal warning by the company requesting the regularization of the fact;

registration lock, losing the right to receive all current and future bonuses at Network Easy Brazil.

In the case of Point Support the cancellation of the PDA is immediate.

If Distributor and / or Point Support identify any irregularities with Policies, Terms and Conditions of Use, Code of Ethics and Regulation of Network Rebate System Easy Brazil, may formalize their complaint by sending an email to Network Easy Brazil: [service @ redefacilbrasil.com.br](mailto:service@redefacilbrasil.com.br).

The information to formalize the complaints should contain consistent data: Pictures; Print screens with date and time; voice or video recording; etc.; something that proves the irregularity and denounced.

If you have information from the registered personal data such as email, phone, sponsor number, social security number or other information linking the person to the Registration Network Easy Brazil, it should be informed as well.

The Easy Network Brazil devotes time and effort to combat irregularities. The accompaniments of complaints are covered by legal secrecy and information about the progress of proceedings are confidential. Therefore, reports on the status of proceedings, investigations or any matter relating to complaints, may not be disclosed.

## **10. How to become a point of support**

Distributor wishing to become a point of support, please send an email to: [pontodeapoio@redefacilbrasil.com.br](mailto:pontodeapoio@redefacilbrasil.com.br).

### 10.1 Requests for foothold

When making a purchase on the website of Easy Network Brazil, the Distributor or Customer may choose the form of withdrawal of the application:

- Easy Network Brazil: In this option, the network Easy will send the application by mail / Carrier according to the shipping options chosen by the customer.
- Point Support: In this option, the customer who should withdraw the application in the chosen point of support. There is no point sending the request for support.

The Distributor or Customer is responsible for paying the freight in both options. In the case of choice of the withdrawal by Point Support, choose the "PAC" option.

Importantly, as the requests made in PDA responsibility for removing the goods is the Customer (reseller).

In both options the customer can choose the means of payment available for Easy Network Brazil: Credit Card, PAGSEGURO, points or Payment on withdrawal.

When you choose to withdraw the application in point of support and the form of payment is bank slip, it must be paid directly at the point of support.

Any product that is paid directly to the PDA will be under full responsibility of receiving and launching the system - the application termination.

### 10.2 Receiving Point Support

When the customer make the purchase on the website of the Network Easy Brazil and choose the point of support, payments will be transferred to the PDA's in the form of points as follows:

Credit card and PAGSEGURO: Once payment is confirmed in the system Network Easy Brazil, the total value of the order, even in installments, it is transferred to the point of support.

Boleto Bancario: You will pay the value of the order directly to the point of support.

Points: Once payment is confirmed by the network Easy Brazil, the value of the points used in the application will be automatically transferred to the point of support.

Point Support may not request redemption or transfer of points, these are exclusively for requesting new orders.

## 11. Sponsorship line

When registering a person is free to choose any sponsor you want.

Every distributor has a guaranteed, safe and secure network, except for exceptions provided for in this Regulation.

The attempt to entice another Distributor to change sponsor or participate in other marketing, will be treated as serious misconduct by Easy Network Brazil.

The registered when faced with the situation of grooming and / or cross-sponsoring, ie a person already registered and another Network distributor convince this person to register in another network with the data of a relative or third parties should make a statement / formal complaint notarized and sent to the central office of the Network Easy Brazil followed by relevant and concrete evidence on solicitation.

Being statement with substantiated facts opens an internal process, reserved, correction.

The Easy Network will compare the old network is not moved and the new network is to drive.

The proven cases of grooming will be subject to the following penalties will be applied both for those who has solicited, and for those who are left entice:

- Notification prepared by the Legal Department of the company;
- Register lock indefinitely;
- Suspension of Registration;
- registration cancellation;
- Network return to proven origin, without authorization (in the case of cross-sponsorship).

### 11.1 Sponsor change

To request change of sponsorship line, must meet the following requirements:

- Develop a personal letter (via email) explaining the situations that motivated to take decision to sponsor change.

After letter of justification, the Network Easy Brazil will send the correct document (via e-mail within 10 business days) for the applicant to provide the signatures of the sponsors involved.

- a) If the network change is to the same level that the applicant is currently up or level the authorization of all sponsors to the meeting of the same network will be required.
- b) If the change is to a descendant level at which the applicant is currently the authorization of all sponsors to the meeting of the same network and to the 8th rising generation will be required.

- c) If the applicant already has joined the company in a period less than six months did not order, or formed activated VIP network, authorization with notarization of the signature of the current sponsor is required.
- d) If the applicant already has joined the company in a period of six months did not order, activated VIP or formed network, the authorization of the current sponsor by email will be required, and this must necessarily be the same email registered in the network Easy Brazil.

The Easy Network Brazil forward for requesting a complete listing and reporting model to collect signatures (with notarization) required to realize the network change.

The sponsor to sign the waiver of the network will be in full knowledge that no longer have any right over bonuses, compensation or any other value from this disconnected network.

The documents should be with the signatures with firm recognized notary and sent to the Central Office Network Easy Brazil, in the registered mail format.

The applicant is responsible for sending the documentation in a single letter to the Office of Network Easy Brazil.

Upon receiving the documentation, the company will review the request and may approve it or reject it. The return will be given no later than thirty (30) days after receipt of the request.

#### 11.1.1 rate

For each network change, there will be a fee of \$ 200.00 (two hundred reais) where the applicant can pay through grade (PV) or bank deposit.

#### 11.2 Independent Distributor of death

In the event of Distributor's death, the registration may be transferred to his heir with agreement of all family made notarized and supported by the other succession rules prevailing in the country.

Any form of succession must be approved by the Legal Department of the Network Easy Brazil before being effective. If there is no inheritance agreement, the network and receiving enter into Judicial inventory and values are retained in the company to this judicial definition without penalty or interest.

In case there is no heir or even interest in business continuity, the registration will be suspended permanently.

It is the responsibility family communicate to the network Easy Brazil on the death of the registered person by the company with certified copy of the death certificate must be submitted to the central office of the Network Easy Brazil.

## **12. other Marketings**

Any Distributor registered on the Web Easy Brazil is free to develop any business, but once registered on the Web Easy Brazil is vetoed by the Company Regulation, invite others who are also registered in the company network Easy Brazil to participate in other business by any means of communication.

A network formed is not unique and exclusive to one person, rather it is a consequence of a work of all who are part of the network and invited other people, who in turn invited other and so on. So invite a registered distributor in Brazil Easy Network is harming other people who contributed to the growth of the network.

Upon confirmation of the above fact through relevant and concrete evidence is introduced a correction process.

Proven cases and offenders are subject to any of the penalties below:

- formal warning;
- Register lock indefinitely;
- Suspension register;
- Penalty of 30% of the bonds purchased in the last 6 months.

## **13. Business Plan suspension Network Easy Brazil**

Permanent discontinuation of Distributor Network Easy Brazil is an event with significant changes to the business network. For this reason, the Network Easy Brazil has clear policies for the event of termination, which can be given as follows:

- voluntary request by the Distributor Network Easy Brazil;
- Breach of the Code of Ethics, Terms and Conditions of Use Policies and Internal Network Easy Brazil.

Regardless of the reasons for the permanent suspension, after their occurrence the Distributor will automatically lose any right on the network who participated.

Consummated termination, the Distributor may only rejoin the network Easy Brazil after five (5) years from the ID suspension date, and return under the beginner status through a new account without any right on the network had before.

In the event of permanent suspension for breach of the Code of Ethics, the acceptance of the Distributor's return rests entirely with the Easy Network Brazil.

However, in such cases, the Distributor Network Easy Brazil should make a new account, the startup condition and undergo the term transcribed in the previous paragraph.

- Read and accept the terms governing its relationship with detailed Easy Network Brazil in the Code of Ethics and this Regulation.
- Buy a VIP Kit to become a distributor or
- Buy consumer products.

By agreeing to the Terms and that register in the system Network Easy Brazil, registered authorizes the use of image in any and all material between documents photos and videos to be used in promotional campaigns and by Institutional Network Easy Brazil. Authorization shall be granted free of charge, covering the use of the image above throughout the country and abroad in the following ways:

The Easy Network Brazil is not responsible for the total or partial payment of benefits to Distributors and / or point of support, or the employees they hire. Each Independent Distributor and / or point of support is responsible for hiring their own health insurance against damage, traffic accidents, disability and others.

#### 4. settings

So you can properly understand the Bonus System, you must be within a few definitions of terms used in everyday life:

##### **Independent distributor**

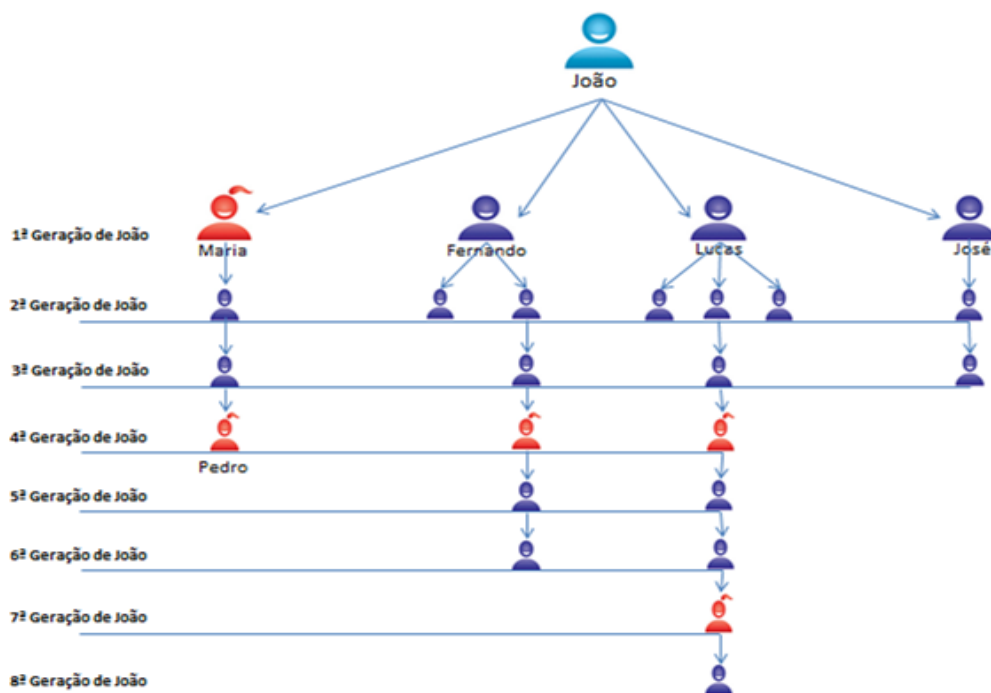

The Distributor will receive bonuses of Kit's Basic to the 5th generation and Kit's VIP to the 8th generation.

The values of PV's are available in the description of each product for sale in the network Easy detailed Brazil by generating site.

In the example of John Network:

Maria bought VIP Kit for \$ 1023.84.

As Mary is the 1st generation of John, he receives R \$ 172.80 so that payment of the order is confirmed in the system.

If Peter, who is registered on the 3rd level of Maria, get a VIP Kit 36 for \$ 1023.84, John will make \$ 23.70 value which is related to the 4th generation.

#### 6.4 Accumulated Point (AP)

It is the accumulated score of the Network. The calculation is monthly and is not cumulative.

When you or one of your guests purchase a product any points are generated, of which 100% will be used to calculate levels (Levels Points).

Following the example of John Network:

Maria bought VIP Kit for R \$ 1023.84, generating 143 PA to John Network. (These values vary according to the price increase).

The table is showing us that John is the 7th level, because accumulated 10,000 points.

Its gross gain on the 7th level was R \$ 2,100.00, but were discounted R \$ 60.00 to pay Network Fernando, R \$ 180.00 of Maria Network, R \$ 270.00 of Lucas Network and R \$ 480.00 of José Network.

### Next 10 Levels

In the next step we will explain another 10 levels, which are: Diplomat, Bronze, Silver, Gold, Platinum, Diamond, Double Diamond, Triple Diamond, Ruby and Sapphire.

These levels are as a complement level 7 because, to achieve any of them before you need to fit into the seventh level.

Table below summarize the minimum number of networks in each classification, how many nets need to have 10 000 points in each level, the sum of minimum points of other networks and finally the gain percentage of these levels:

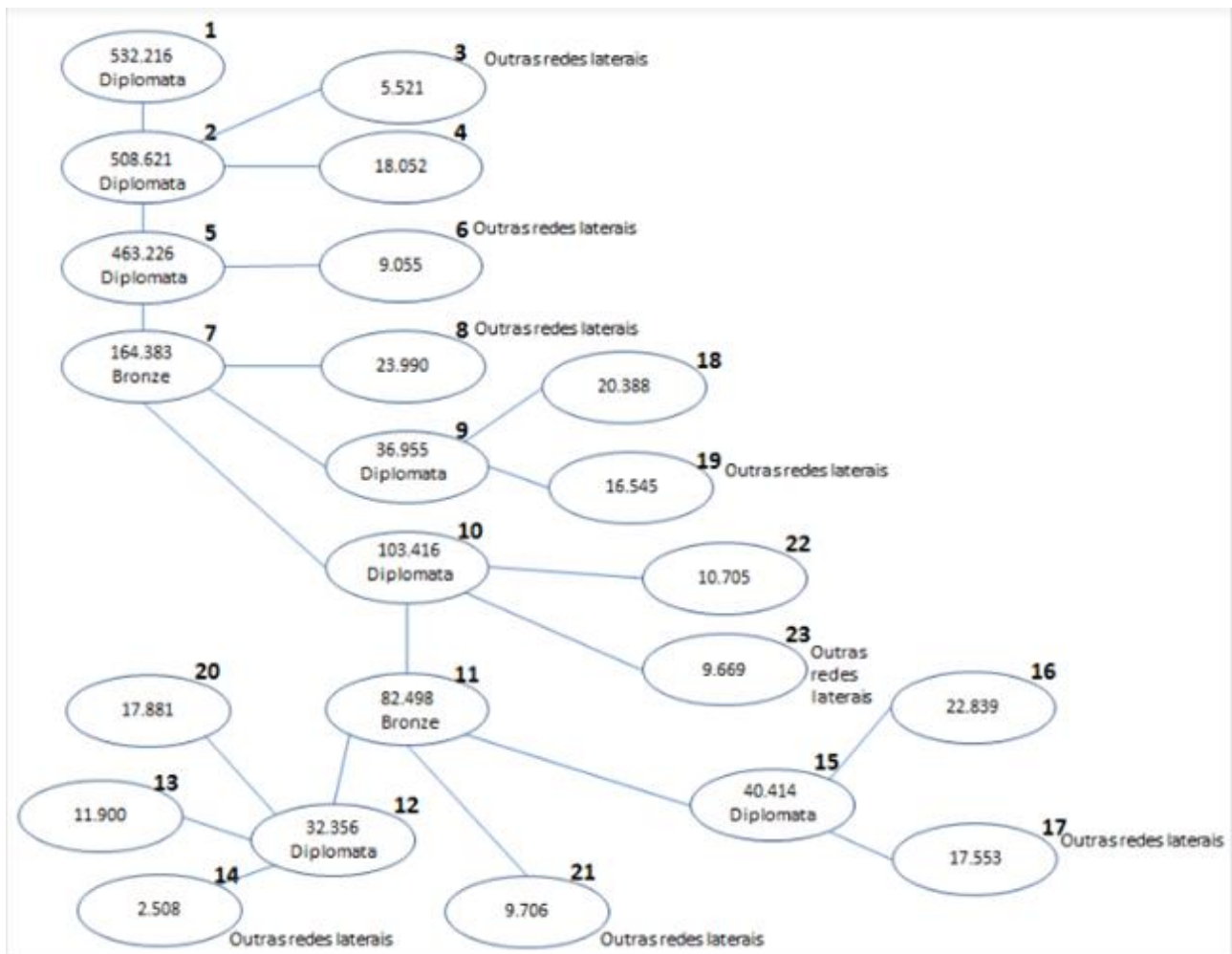

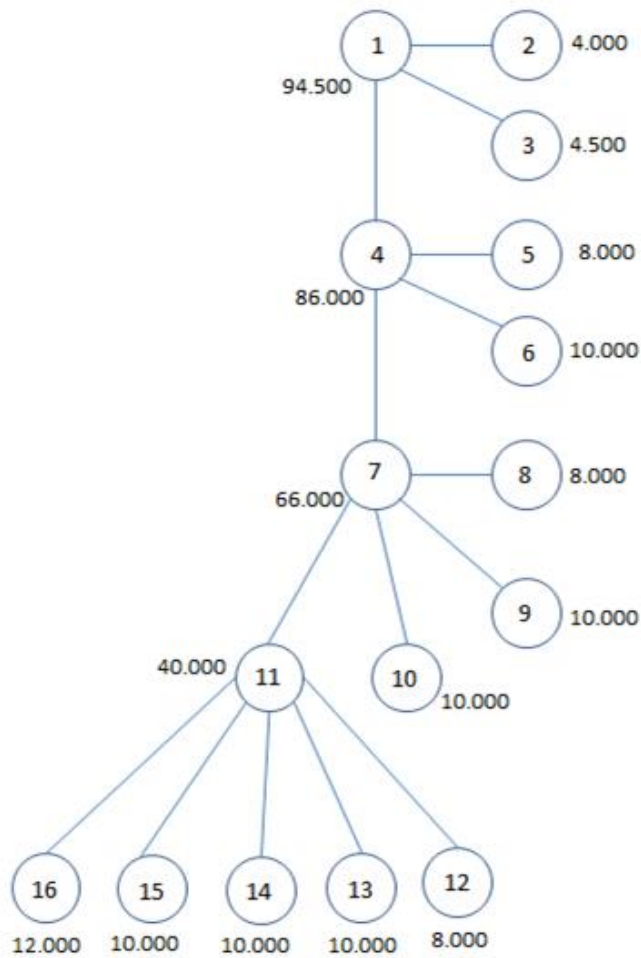

### CLAUSE. Of the object

It is the object of this contract purchase and sale and distribution of products in the country, included in the EASY NET BRAZIL site (electronic [www.redefacilbrasil.com.br](http://www.redefacilbrasil.com.br)).

### CLAUSE. The rules and norms that have governed this contract

This agreement shall be governed solely by the rules and regulations described in the TERMS AND CONDITIONS OF USE, in accordance with the law and art. 485, Civil Code.

First paragraph. NETWORK EASY BRAZIL available to all distributors in your site [www.redefacilbrasil.com.br](http://www.redefacilbrasil.com.br). The rules and terms of use and other conditions governing the contract in its entirety, being an integral part thereof, stating herein that all terms and conditions are known to the DISTRIBUTOR, serving the access and registration as electronic signatures and unequivocal science.

Second paragraph. NETWORK EASY BRAZIL make available on the site [www.redefacilbrasil.com.br](http://www.redefacilbrasil.com.br) in its entirety and all necessary information to become a DISTRIBUTOR, being an integral part of this agreement the TERMS AND CONDITIONS OF USE, DELIVERY POLICY, the PAYMENT POLICY, PRIVACY POLICY, the EXCHANGE POLICY AND RETURNS, OF REGULATION THE BONUS SYSTEM and the Code of Ethics.

Paragraph Three. The Code of Ethics, named Network of Ethics Easy Brazil, covers all the features of NETWORK EASY TO BRAZIL, as well as the duties and DISTRIBUTOR obligations, cogent rules, regulations and assessment and treatment violations, which must be adhered to strictly by DISTRIBUTOR, whose terms the parties state accepted from the moment they proceed to register in the EASY NET BRAZIL site, considered as electronic signature without reservation.

Paragraph One. After effected the Register, the DISTRIBUTOR shall send to the EASY NET BRAZIL copy of all the documents that formed the basis for the registration as well as documents proving residence and Marital Status, within thirty (30) days after digital signature perfectibilizada under this contract, under penalty of suspension of the Distribution Agreement for Reseller Products NETWORK EASY BRAZIL and its Approved Suppliers.

Paragraph Two. EASY BRAZIL NETWORK will only have given their acceptance to the contract at the time it was proceeded the examination and approval of the documents submitted without obligation before that, may accept or reject the contract without justification, reserving the right to in its sole discretion to refuse any proposal for accreditation in any way the products of your brand and its Approved Suppliers without

the need to justify the reason for his refusal, given that in these cases the amounts invested for the purchase acquisition will be returned to alleged case Distributor has not yet removed the goods, or if you do not have outstanding debt with the EASY NET BRAZIL, serving the values for compensation.

Paragraph Three. This contract shall only take effect as from the acceptance of EASY NETWORK BRAZIL, and, if not accepted, there is no obligation between the parties, nor generate any rights be it capacity whatsoever.

Paragraph Four. All information provided by DISTRIBUTOR, will be taken as true by NETWORK EASY TO BRAZIL, which is responsible solely and exclusively for the veracity of the same, whose conference does not exempt the DISTRIBUTOR of responsibilities for the accuracy and reliability of the information provided by it, without any form of solidarity and subsidiarity between the EASY NET BRAZIL and the DISTRIBUTOR.

Paragraph Five. Will only be accepted and considered valid the completed registration clearly and in the manner described in the NET EASY BRAZIL site, being prohibited the registration or registration of the same CPF for more than once.

Paragraph Six. Will only be accepted and considered valid the Registry of a single CNPJ by a legal entity, be it mother or affiliate.

Paragraph Seven. Any company or individual of legal age or emancipated considered able, under the Civil Code, you may request your registration as DISTRIBUTOR the manner and conditions described in this contract and provided it is not prevented from marketing or other impediment that makes it unfit for the exercise of trade, will be obliged to inform the EASY NET BRAZIL, on any impediments, and its omission will be punished with the immediate termination of the contract without prejudice to other civil and criminal penalties.
